TERMS AND CONDITIONS

- Payments should be made **on** or **prior** to the start of the term.
- The bus will leave at the scheduled time. If the child is not at the pick-up point at the scheduled time, it is the responsibility of the parent/guardian to get the child to school.
- At drop off, every child under 6 years **must** be accompanied by someone. If there is no one to pick them up, they shall be returned to school and picked from there by the parent/guardian.
- There shall be **no** door-to-door services offered. Pick up and drop off is strictly at the zone points.
- Though we will always strive for on time performance, due to unforeseen circumstances, please note that pick up or drop off time estimates are +/- 15 minutes scheduled time.
- The school shall **not** provide refunds or credit for absences, cancellations, holidays, school breaks, sick days, expulsions or suspensions.
- Due to consideration for all our students, maximum wait time at each stop is **three** minutes. If the child is not at the designated point, the bus will depart at driver's discretion.
- The school reserves the right to cancel the agreement without notice at any time due to disciplinary problems with a child while riding the vehicle. Children must be well behaved in the bus and accept the authority of the driver and caregiver. Those routinely misbehaving will be strictly reprimanded and in a case of repeated behaviour may be deprived of the school bus facility at the discretion of the school management.
- The school is not responsible for the health, safety or welfare of your child once he/she is dropped off at the agreed destination.
- Cost to any damage to our vehicles caused by a rider is the responsibility of the parent/guardian.
- Any dispute, controversy or claim that may arise or breach, termination or invalidity thereof shall be settled by arbitration.
- All matters of emergency should be brought to the attention of the **administrator** and not the driver or caregiver. This shall apply to any changes in address or phone number.
- Children will be provided with a bus pass and are expected to have them at all times while travelling on the bus, during home time and in the morning pick up time. In the absence of the pass, the school can deny access to the transportation service.
- School transportation is subject to availability. If it is impossible, ample notice will be communicated.
- A notice of one month must be given should one choose to terminate use of the bus service, failure to which one month's fee in lieu of notice will be charged.
